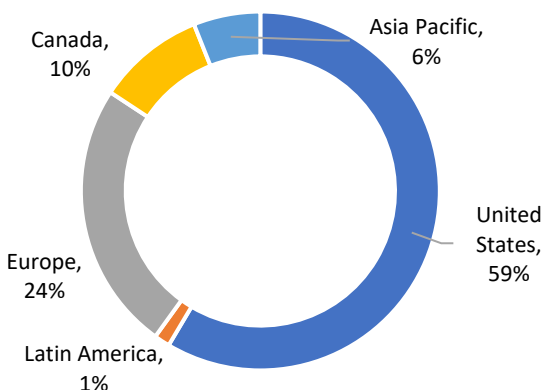

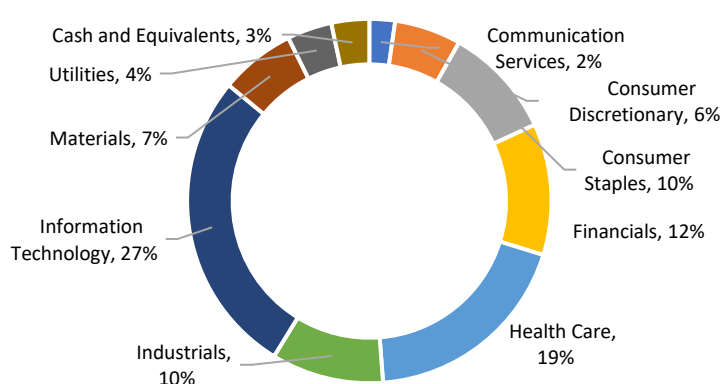

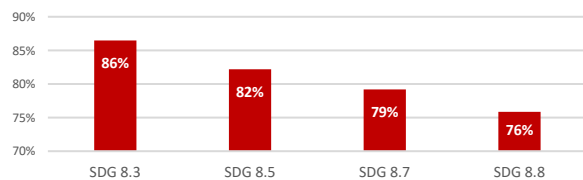
SDG Goal Score (%) of the portfolio (Dec 31, 2025)

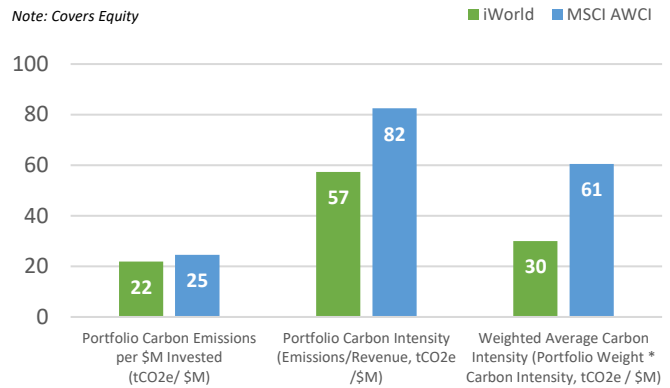

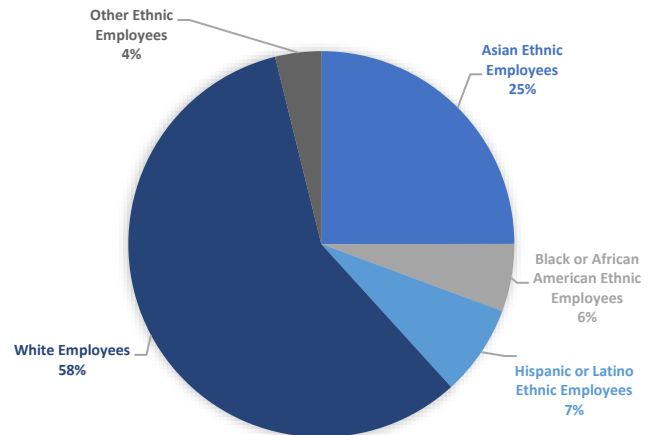
Portfolio Carbon Footprint vs Benchmark (Scope 1 & 2 Emissions)

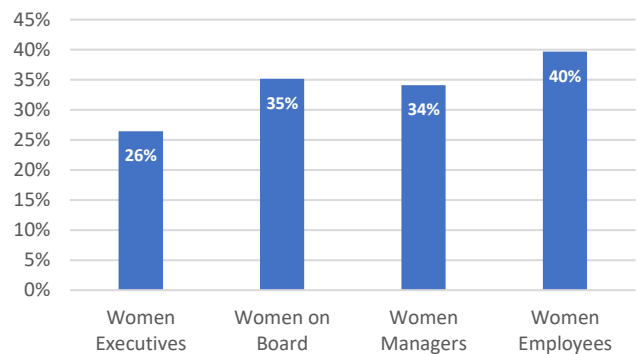
